

**RESOLUTION APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES CONTAINED IN THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF MONCADA FOR CALENDAR YEAR 2019 IN THE TOTAL AMOUNT OF THIRTY ONE MILLION SIX HUNDRED EIGHTY THOUSAND PESOS AND 00/100 (Php 31,680,000.00) TO BE FUNDED OUT FROM THE SUPPLEMENTAL BUDGET**


