CONFIRMING AND AFFIRMING THE APPOINTMENT OF MR. VON MARK D. CORPUZ AS FULL-FLEDGED MUNICIPAL ACCOUNTANT OF MONCADA LOCAL GOVERNMENT UNIT

WHEREAS, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided herein, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, Article 4 Section 474 of the same Code provides that no person shall be appointed accountant unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, and a certified public accountant. He must have acquired experience in the treasury or accounting service for at least three (3) years;

WHEREAS, the appointment of a municipal accountant is mandatory for the municipal governments;

WHEREAS, the appointment of Von Mark D. Corpuz, Municipal Accountant, is in order having met the minimum requirements provided by law;
