WHEREAS, the construction of a Local Access Road in Barangay Ablang-Sapang is a priority program and/or project to be funded from the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF-FA to LGUs) shall be implemented by the Municipality concerned;
