WHEREAS, in order to minimize, if not totally eradicate the said problem, there is an urgent need for the desiltation and restoration of the said natural waterway;

WHEREAS, the restoration thereof will not only control floods in the area, but likewise render the nearby lands productive again and provide livelihood opportunities to the affected residents;


