#### RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH VARIOUS SCHOOLS IN THE MUNICIPALITY FOR THE USE OF THEIR FACILITIES AS EVACUATION CENTERS DURING ONSLAUGHT OF CALAMITIES

WHEREAS, the municipality has only a few number of evacuation centers and there exists an imperative need to enter into an agreement with various educational institutions that have signified their readiness to have their facilities utilized in times of disasters;

WHEREAS, the Local Chief Executive submitted a request to this August Body seeking authorization to enter into a Memorandum of Agreement with various schools for the above-mentioned purpose;

WHEREAS, the foregoing request is found to be in order and meritorious of approval;

NOW, THEREFORE, on motion by COUN. RODOLFO C. ESPEJO, JR., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Peace and Order, Public Safety and Security hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a Memorandum of Agreement with various schools in the Municipality for

  - 2. Component schools under Moncada North District represented by Dr. Roger P. Ramos (District Supervisor)
  - 3. Component schools under Moncada South District represented by Dr. Ricky Junio (District Supervisor)

REOLVED FURTHER, that this authorization shall be valid for three (3) years, commencing upon the approval hereof until June 30, 2022;
