RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PRIVATE TRADERS FOR THE AVAILMENT OF LOAN PROGRAM DURING DISASTERS

WHEREAS, the Local Government Unit is mandated to promote the general welfare of its people and protect them from the adverse effects of calamities;

WHEREAS, the LGU is authorized to set aside five percent (5%) of its annual budget for the LDRRM Fund, from which the thirty percent (30%) thereof shall be allocated as Quick Response Fund (QRF) which shall be disbursed during onslaught of disasters;

WHEREAS, to hasten government's efforts to address the needs of the constituents, several private traders expressed willingness to grant a loan program to the LGU;

WHEREAS, the foregoing agreement shall materialize through the execution of a Memorandum of Agreement between the LGU, through the Local Chief Executive and the proprietors/owners of these business entities;
