RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH A THIRD-PARTY PSYCHOLOGIST OR PSYCHOMETRICIAN FOR THE PROVISION OF PSYCHOSOCIAL SUPPORT SERVICES IN TIMES OF DISASTERS

WHEREAS, the Local Government Unit is mandated to promote the general welfare of its people and protect them from the adverse effects of calamities;

WHEREAS, recognizing the psychological disturbances that may affect the populace during disasters, there exists an imperative need to establish an agreement with a psychosocial support provider who will address the mental health needs of affected individuals and families;

WHEREAS, the foregoing agreement shall materialize through the execution of a Memorandum of Agreement between the LGU, through the Local Chief Executive and a Registered Psychologist or Psychometrician, as the case may be;

NOW, THEREFORE, on motion by COUN. ALBERTO C. MARZAN, JR, MD, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Social Welfare, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a Memorandum of Agreement with a third-party Psychologist or Psychometrician for the provision of psychosocial support services in times of disasters;
