RESOLUTION RATIFYING AND ENDORSING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC AND THE NATIONAL FOOD AUTHORITY (NFA) TARLAC PROVINCIAL OFFICE, IN REGARD TO RICE ON CASH AND CREDIT PROGRAM

WHEREAS, under the Local Government Code, LGUs are authorized to set aside 5% of their regular income for LDRRM Fund to ensure prompt and efficient delivery of basic social services in times of calamities;

WHEREAS, relative to this, the NFA is implementing a Rice Loan Program wherein the LGUs are allowed to purchase Rice on Cash and Credit basis from the said national government agency;

WHEREAS, under the program, the Rice Loan is intended for relief operations whenever a state of calamity is declared in the locality and for stockpiling in preparation for eventualities/emergencies that may occur at any given time;

WHEREAS, the LGU of Moncada and the National Food Authority have entered into a Memorandum of Agreement for the foregoing Rice Loan Program on August 14, 2019, with authorization from this Sanggunian by virtue of Resolution No. 69, Series of 2019 dated July 10, 2019;

NOW, THEREFORE, on motion by COUN. RUBEN V. GAMBOA, JR. and unanimously seconded;
