RESOLUTION AUTHORIZING VICE MAYOR JAIME O. DUQUE, DESIGNATED AS ACTING LOCAL CHIEF EXECUTIVE, TO SIGN CHECKS AND ALL WARRANTS DRAWN FOR THE EXPENDITURES OF THE MUNICIPALITY OF MONCADA EFFECTIVE AUGUST 27, 2019 UNTIL SEPTEMBER 8, 2019

WHEREAS, Honorable Mayor Estelita M. Aquino, Local Chief Executive of Moncada, Tarlac has filed her leave of absence from August 27, 2019 to September 8, 2019;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, specifically Section 46, provides that the Vice Mayor shall exercise the powers and perform the duties and functions of the Municipal Mayor in case of temporary vacancy, except for the power to appoint, suspend and dismiss employees;

WHEREAS, the Sangguniang Bayan and the Office of the Vice Mayor are in receipt of an Office Order dated August 20, 2019 designating the Honorable Vice Mayor Jaime O. Duque as Acting Local Chief Executive effective August 27, 2019 until September 8, 2019;

WHEREAS, under Section 444 (b) (vi) of the Local Government Code of 1991, the Local Chief Executive has the authority to sign checks and all warrants drawn from the municipal treasury intended for the operation of the municipality, to which appropriations therefor shall be derived from the GENERAL FUND (GF), TRUST FUND (TF) and SPECIAL EDUCATION FUND (SEF);

WHEREAS, the foregoing duties shall therefore be assumed by Vice Mayor Jaime O. Duque during the course of his designation as Acting Local Chief Executive;


NOW, THEREFORE, premises considered and on motion by Coun. Cleofe D. Favis, unanimously seconded in session assembled;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby authorizes Vice Mayor Jaime O. Duque, designated as acting Local Chief Executive, to sign checks and all warrants drawn for the expenditures of the Municipality of Moncada effective August 27, 2019 until September 8, 2019;
