**REQUESTING PLAZA TODA TO AMEND ITS BY-LAWS, SPECIFICALLY ITEM NUMBER 17, TO ALLOW THE ENTRY OF AT LEAST ONE TO TWO (1-2) NEW MEMBERS EACH YEAR TO ACCOMMODATE THE INCREASING DEMAND FOR PUBLIC TRANSPORTATION IN THE MUNICIPALITY**

WHEREAS, it has reached the attention of the Sangguniang Bayan that PLAZA TODA refuses to admit new members in their group pursuant to their approved By-Laws;

WHEREAS, the matter was referred to the Committee on Public Works, Utilities, Infrastructure and Games and Amusements for preliminary investigation;

WHEREAS, the foregoing committee after validating the report now submits its recommendation calling for the amendment of an item in their By-Laws;

WHEREAS, the said issue involving the refusal of Plaza TODA to allow entry of new members is deemed prejudicial to the interest of the riding public, whose demand for public transportation has been on continuous upturn over the past years;

NOW, THEREFORE, on motion by Coun. Celeste A. Ayson, duly seconded by Coun. Janius M. Yasay in session duly assembled;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Public Works, Utilities, Infrastructure and Games and Amusements, hereby requests Plaza TODA to amend its By-Laws, specifically item number 17, to
