RESOLUTION ENDORSING THE CONSTRUCTION OF A LOCAL ACCESS ROAD CONNECTING TO A FARM-TO-MARKET ROAD IN BARANGAY STA. MONICA AS A PRIORITY PROJECT AND AFFIRMING SUCH PROJECT AS PART OF THE DULY APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM AND ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY.

WHEREAS, the construction of a Local Access Road in Barangay Sta Monica is a priority project to be funded from the Local Government Support Fund – Financial Assistance to Local Government Units (LGSF-FA to LGUs) which shall be implemented by the Municipality concerned;
