**AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2021 FOR FISCAL YEAR 2021 OF THE MUNICIPAL GOVERNMENT OF MONCADA, IN THE TOTAL AMOUNT OF FOUR MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P 4,250,000.00)**

**SECTION 1.** Supplemental Budget No. 1 for Fiscal Year 2021 of the Municipal Government of Moncada, in the total amount of **FOUR MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P 4,250,000.00)** is hereby approved.


