## APPROPRIATION ORDINANCE NO. 02 Series of 2021

AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2021 OF THE MUNICIPAL GOVERNMENT OF MONCADA, IN THE TOTAL AMOUNT OF ONE HUNDRED FIVE MILLION PESOS (P 105,000,000.00) FOR THE EXPANSION OF EXISTING PUBLIC MARKET, CONSTRUCTION OF SLAUGHTERHOUSE AT BRGY. BURGOS AND CONSTRUCTION OF MUNICIPAL CEMETERY III AT BRGY. CAMPOSANTO I NORTE

**WHEREAS**, the Honorable Mayor Estelita M. Aquino is endorsing to this August Body the proposed Supplemental Budget No. 2 for CY 2021, to provide appropriation for the Expansion of Public Market, Construction of Slaughterhouse at Brgy. Burgos And Construction of Municipal Cemetery III at Brgy. Camposanto I Norte;

**SECTION 1.** Supplemental Budget No. 2 for Fiscal Year 2021 of the Municipal Government of Moncada, in the total amount of **ONE HUNDRED FIVE MILLION PESOS (P 105,000,000.00)** is hereby approved.
