RESOLVED, as it is hereby resolved to promulgate Ordinance No. 2 s 1979, and  
Ordinance creating the MONCADA SPORTS DEVELOPMENT COUNCIL.

-Ordinance No. 2-  
Series of 1979

WHEREAS, the Ministry of youth and Sports Development of the Republic of the Philippines enjoin all barangays municipalities and provinces to encourage and enhance youthdevelopment to become fit and morally upright citizens;

WHEREAS, the sangguniang Bayan of Moncada,in order to keep abreast with the avoed national objectives and to properly pursue the same, the Sangauniaang Bayan in seassion assembled, expresses itself in accord unconditionally with the same aim and objectives;

NOW THEREFORE, on motion by Kgd.Alfredo M. Gonzales and duly seconded unanimously, it has been moved to create an Office to oversee, manage and direct the sport activities of the youth of Moncada.

SECTION 1 – The Office shall herein after be known as the MONCADA SPORTS DEVELOPMENT COUNCIL (MSDC).

SECTION 2 – The MSDC shall be composed of an Executive Chairman and council members, the members of which shall be appointed by the Executive Chairman, and shall hold office for a period of FOUR (4) years from date of appointment.

SECTION 3 – The MSDC shall be empowered to promulgate rule and regulations governing youth sports activities and adopt such rules and regulations from time to time or amend the same as the need warrants to cope with arising and unforeseen contingencies.

SECTION 4 – No sporting event of any kind maybe held in the municipality without the sanction of the MSDC.

SECTION 5 – The Executive Chairman and the members of the MSDC shall hold office without salary or renumeration unless otherwise the Sangguniang Bayan ordain and appropriate the necessary funds therefore.

This Ordinance and all necessary pertinent appendices shall take effect upon approval hereof.

RESOLVED, as it is hereby resolved to set aside and appropriate the amount of FIVE HUNDRED (500.00) PESOS from any funds not otherwise appropriated as aid to a one day Tour of Tarlac in cycling to be staged on May 20, 1979 to represent the region to the National Championship in June;

RESOLVED FURTHER, that copies of this resolution be furnished Mr. Jesus T. Caparas, Cycling Commission, Region III for information and guidance;

RESOLVED FINALLY, that copy of this resolution be furnished the Municipal Treasurer of Moncada, Tarlac for information and appropriate action.
