#### **SECTION 1: Title**

This Ordinance shall be known as the "**Benito E. Aquino Excellence Award Ordinance.**"

#### **SECTION 2: Establishment of the Benito Excellence Award**

The Benito Excellence Award is hereby established as a token of merit conferred upon exceptional individuals from Moncada who have showcased outstanding contributions in various fields, including but not limited to Academics, Innovation, Projects, Sports, and Arts.

#### **SECTION 3: Criteria for Award**

The criteria for the Benito E. Aquino Excellence Award shall be determined by the Awards Committee, considering the exemplary achievements and notable impact of the awardees in their respective fields.

#### **SECTION 4: Awards Committee**

There shall be a Benito E. Aquino Excellence Awards Committee composed of members appointed by the Mayor, which shall be responsible for selecting the recipients of the award based on the established criteria.

#### **SECTION 5: Award Presentation**

The award shall be presented annually in a ceremony held on a date to be determined by the Committee, where the recipients shall be recognized and honored by the Municipal Government of Moncada, Tarlac.

#### **SECTION 6: Funding**

The necessary funds for the implementation of this Ordinance shall be regularly allocated from the Annual Budget of the Municipality of Moncada.

#### **SECTION 7. Separability Clause**

If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall remain in full force and effect.

#### **SECTION 8: Repealing Clause**

All ordinances or parts thereof that are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

#### **SECTION 9: Effectivity**

This Ordinance shall take effect immediately upon approval.


