MUNICIPAL ORDINANCE NO. 18
Series of 2022

AN ORDINANCE MANDATING THE EMPLOYMENT OF SECURITY PERSONNEL IN CONVENIENCE STORES AND OTHER ESTABLISHMENTS OPERATING TWENTY-FOUR HOURS A DAY, SEVEN DAYS A WEEK, PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND OTHER PURPOSES

WHEREAS, in a letter dated November 3, 2022 submitted by the Moncada Police Station to this August Body, the Chief of Police noted the series of robbery incidents involving convenience stores and other 24/7 establishments which have become frequent targets of such crime due to lack of responding security personnel;

WHEREAS, with the PNP being concerned about possible worse-case scenarios, the same is requesting that an Ordinance be enacted to require 24/7 convenience stores, gasoline stations, and other similarly operating establishments to hire their respective security personnel to abate, and consequently avert the occurrence of robbery crimes in the municipality which target these kinds of establishments;

BE IT ENACTED by the Sangguniang Bayan of Moncada in session assembled, that:

SECTION 1. Statutory Provisions. (a) Business establishments operating twenty-four hours a day, seven days a week such as convenience stores and gasoline stations, and those with voluminous monetary transactions such as banks, lending institutions, remittance centers, pawnshops and other businesses with similar vulnerabilities shall be required to hire security personnel as a deterrent measure against criminal activities.

(b) Proof of compliance of business establishments such as, but not limited to appointment letter/designation from security agency or employer, employment contract, or social insurance contributions, shall be submitted to the Business Permits and Licensing Office (BPLO) of this LGU upon application for or renewal of Business Permit.

SEC. 2. Implementation and Monitoring. (a) Within thirty (30) days from the effectivity of this Ordinance, business establishments covered under this Ordinance shall comply with the statutory provisions under Section 1 hereof.

(b) A monitoring team to be comprised of personnel from the Office of the Mayor, BPLO and the Philippine National Police shall be directed to ensure the effective and efficient implementation of this Ordinance.

SEC. 3. Penalties. Non-compliance with Section 1 of this Ordinance shall have corresponding penalties, to wit:

- a) A moratorium of five (5) working days shall be given to the owner of the business establishment within which to comply with the Ordinance.
- b) Suspension of business operations for fifteen (15) days for failure to comply after the moratorium.
- c) Revocation of business permit for continued non-compliance.

SEC. 4. Separability Clause. If any provision of this Ordinance is determined to be invalid, illegal or unenforceable, the remaining provisions thereby shall remain in full force and effect.

SEC. 5. Repealing Clause. All Ordinances and resolutions or any parts thereof which are inconsistent with the foregoing provisions are hereby repealed or modified accordingly.

SEC. 6. Effectivity Clause. This Ordinance shall take effect fifteen (15) days following its posting in at least three (3) conspicuous places in the municipality and likewise in the website and official social media platforms of the SB and LGU of Moncada.
