MUNICIPAL ORDINANCE NO. 04 Series of 2020

AN ORDINANCE GRANTING A ONE-TIME LONGEVITY BONUS TO LIVING ELDERLY RESIDENTS OF MONCADA UPON REACHING THE AGE OF NINETY (90) YEARS BEFORE OCTOBER OF EVERY YEAR

WHEREAS, in the context of this Ordinance, the elderly are presumed to have outlived their productive years and are now mostly confined in the comfort of home under the care of their immediate family;

WHEREAS, the fact about their having contributed something significant to society during their prime no matter how trifling small, cannot be ignored, nor the recognition be denied them;

WHEREAS, as a token of gratitude for the good they may have made of what we are today, it is but appropriate that such shall be recognized with a nine thousand-peso (P9,000.00) longevity bonus to be awarded every October during the "Elderly Week;"

NOW, THEREFORE, on joint motion by Coun. Dr. Alberto C. Marzan, Jr. and Coun. Cleofe D. Favis, duly seconded;

BE IT ENACTED by the Sangguniang Bayan of Moncada in session assembled that:

SECTION 1. Short Title. – This Ordinance shall be known as the **“Longevity Ordinance of Moncada 2020”**

SEC 2. Longevity Bonus. – An amount of not less than nine thousand pesos (P9,000.00) shall be granted to elderly residents of Moncada aged ninety (90) years as of September 30 of every year.

SEC 3. Eligibility. – No elderly, aged 90 years and above at the time of approval of this ordinance, shall be granted longevity bonus unless he/she presents proof of his/her age, residency and he/she is a qualified member of the Senior Citizens of Moncada, duly certified by the head of Office of the Senior Citizens Affairs (OSCA) of the municipality.

SEC 4. Funding. – The Municipal Government of Moncada shall appropriate the necessary funds for the grant of longevity bonus to elderlyies ninety (90) years of age, subject to the usual accounting and auditing law, rules and regulations.

SEC 5. Implementation. – The Local Chief Executive, through the Municipal Social Welfare and Development Office (MSWDO) and Office of the Senior Citizens Affairs (OSCA) shall be authorized to grant longevity bonus to all qualified elderlyies during the “elderly week” in October of every year.

SEC 6. Separability Clause. – If for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

SEC 7. Repealing Clause. – All ordinances, rules and regulations or parts thereof in conflict with this Ordinance are hereby repealed or modified accordingly.

SEC 8. Effectivity Clause. – This Ordinance shall take effect upon its approval.
