**ORDINANCE PRESCRIBING THE 2022 REVISED SCHEDULE OF  
TRICYCLE FARES IN THE MUNICIPALITY OF MONCADA**

**Sponsored by: COUN. CONSTATE NESTOR A. FAVIS**

*Chairperson, Committee on Public Works, Utilities and Transportation*

**WHEREAS**, Article 3, Section 447(3)(vi) of RA 7160 or the Local Government Code of 1991 empowers the Sangguniang Bayan to regulate the operation of tricycles and grant franchises for their operations within the territorial jurisdiction of the municipality;

**WHEREAS**, in the advent of the COVID-19 pandemic, legislative measures and issuances were passed to adjust tricycle fare matrix in consideration of the restrictions imposed by the Inter-Agency Task Force on the Management of Emerging Infectious Diseases (IATF-EID) that rendered tricycle operators grapple with the adverse effects of the health and economic crisis on their source of livelihood;

**WHEREAS**, taking into account the plight of tricycle operators adversely affected by the health and economic crisis and the unabated increase of fuel prices in the country, the lifting of number coding scheme and the re-adjustment of tricycle fares were recommended by the Municipal Motorized Tricycle Franchising and Regulatory Board (MTFRB) and the Sangguniang Bayan Committee on Public Works, Utilities and Transportation during their meeting with TODA Representatives last March 11, 2022 at the Municipal Motorpool;

**SEC. 2.** Tricycle operators granted with franchise and Mayor's Permit shall comply with all rules and regulations and traffic management ordinances imposed by the Municipal Government of Moncada through the Motorized Tricycle Franchising and Regulatory Board (MTRFB) and the LGU's Traffic Management Unit.

**SEC. 3.** If any provision or part hereof is held invalid or declared unconstitutional, the other provisions which are not affected thereby shall continue to be in full force and effect.

**SEC. 4.** All issuances, rules and regulations or parts thereof which are in conflict with this Ordinance are hereby repealed or modified accordingly.

**SEC. 5.** This Ordinance shall take effect immediately upon its approval.

**ENACTED**, this 11<sup>th</sup> day of March, 2022 at Moncada, Tarlac.
