MUNICIPAL ORDINANCE NO. 14

AN ORDINANCE PRESCRIBING SHORTENED SCHEDULE OF WAKES FOR NON-COVID DECEASED CASES IN THE MUNICIPALITY AMID THE COVID-19 PANDEMIC

PREAMBULAR CLAUSE

WHEREAS, the unabated increase in COVID-19 cases despite efforts to contain it by all means should create a sense of urgency from the LGU to act with dispatch and efficacy;

WHEREAS, stringent preventive measures are hereby reimposed to preclude the spread of the virus. These include the regulation of mass gatherings such as wakes, funeral rites and interment of the deceased;

NOW, THEREFORE,

On motion by Coun. Alberto C. Marzan, Jr., duly seconded:



SANGGUNIANG BAYAN

Be it ENACTED by the Sangguniang Bayan of Moncada in session assembled, that:

SECTION 1. General Statutory Provisions:

- a. Public viewing for non-COVID deceased cases shall be limited to a maximum five (5) days, reckoned from the day the wake started.
- b. Visitors and guests from outside the Province attending the wake shall be limited to first-degree family members only and shall undergo IATF protocols upon arrival.
- c. Minimum health standards shall remain strictly enforced such as, but not limited to, wearing of face mask and appropriate physical distancing protocols.
- d. Any kind of game of chance and consumption of liquor and alcoholic products shall not be allowed during wakes.
- e. The number of attendees shall be limited to fifty (50) persons at any given time, corresponding to the area capacity where the wake is in observance of health protocols.
- f. Curfew hours shall be observed from 11:00pm until 4:00am of the next day pursuant to Provincial Ordinance No. 12-2020.
- g. Persons below 15 and above 65 years old shall not be allowed to attend wakes, except for immediate family members.

SEC 2. Penalty. – Persons found violating Section 1 (d) of this Ordinance shall be fined two thousand five hundred pesos (P 2,500.00) to be settled at the Municipal Treasury.

SEC 3. Implementation. - The Municipal Health Office (MHO), Philippine National Police (PNP), Department of Health (DOH), and Liga ng mga Barangay (LnB) are hereby directed to enforce the above-mentioned guidelines.

SEC 4. Repealing Clause. – All ordinances, issuances, rules, and regulations or any part thereof which are inconsistent with the provisions hereof are hereby repealed, amended or modified accordingly.

SEC 5. Effectivity. – This Ordinance shall take effect immediately upon approval and shall be in effect for as long as the Pandemic threat exists.
