**GRANTING RECOGNITION AND INCENTIVES TO MONCADA-BASED LEARNERS WHO WIN IN INTERNATIONAL, NATIONAL, REGIONAL, AND PROVINCIAL COMPETITIONS AS OFFICIAL DELEGATES**

**WHEREAS**, the Municipality of Moncada recognizes the exceptional talents and skills possessed by its learners in various fields of endeavor;

**WHEREAS**, the achievements of Moncada-based learners who participate and excel in international, national, regional, and provincial competitions reflect positively on the reputation of the Municipality and the Republic of the Philippines as a whole;

**WHEREAS**, it is the duty of the local government to encourage and support the pursuit of excellence in various fields of competition and to recognize the dedication and hard work of its learners;

**NOW, THEREFORE**, on motion by Coun. Dean Michael V. Duque, duly seconded by Coun. George Michael V. Aguilar;

**BE IT ENACTED** by the Sangguniang Bayan of Moncada, Tarlac, in session assembled, that:

**SECTION 1. TITLE.** This ordinance shall be known as the **"Moncada Learner Achievement Recognition and Incentives Ordinance."**

**SEC. 2. DEFINITION OF TERMS.** For the purpose of this ordinance, the following terms shall be defined as follows:

- a. Learner: Refers to any student, pupil, or individual enrolled in an educational institution within the jurisdiction of Moncada, Tarlac.
- b. International Competition: A competition in which participants from various countries compete against each other in a specific field of endeavor.
- c. National Competition: A competition organized and sanctioned by a national governing body or agency in the Philippines.
- d. Regional Competition: A competition organized within Central Luzon, which may consist of several provinces or municipalities.
- e. Provincial Competition: A competition organized within the boundaries of Tarlac Province.

**SEC. 3. RECOGNITION AND INCENTIVES.** Moncada-based learners who win or secure notable achievements as official delegates in international, national, regional, and provincial competitions shall be accorded the following recognition and incentives:

- a. A formal recognition and commendation from the Municipality of Moncada through a certificate of recognition signed by the Municipal Mayor and the Sangguniang Bayan through the Presiding Officer.
- b. A cash incentive based on the level of competition, as follows:
  - b.1 International and National Competitions:
    - Gold Medalist / First Placer – Five Thousand Pesos (P 5,000.00)
    - Silver Medalist / Second Placer – Three Thousand Pesos (P 3,000.00)
    - Bronze Medalist / Third Placer – Two Thousand Pesos (P 2,000.00)
  - b.2 Regional and Provincial Competitions:

Individual and Group Events

    - Gold Medalist / First Placer – Three Thousand Pesos (P 3,000.00)
    - Silver Medalist / Second Placer – Two Thousand Pesos (P 2,000.00)
    - Bronze Medalist / Third Placer – One Thousand Pesos (P 1,000.00)
- c. Public acknowledgment and presentation of the achievement during appropriate local government events, celebrations, or ceremonies.

**SEC. 4. PROCEDURE FOR CLAIMING RECOGNITION AND INCENTIVES**

- Learners who have won or achieved excellence in international, national, regional, and provincial competitions shall present proof of their participation and achievement to the Office of the Mayor.
- The Local Government shall establish a committee to review and verify the submitted documents, ensuring that the achievements and participation of the learners meet the criteria set forth in this ordinance.
- Once the verification process is completed, the committee shall recommend the appropriate recognition and incentives to the Municipal Mayor for approval.

**SEC. 5. APPROPRIATION OF FUNDS.** The necessary funds for the implementation of this ordinance shall be appropriated from the Annual Budget of the Municipal Government of Moncada.

**SEC. 6. SEPARABILITY CLAUSE.** If any provision of this ordinance or its application to any person or circumstances is declared invalid, the remainder of the ordinance or the application of the provisions to other persons or circumstances shall not be affected.

**SEC. 7. REPEALING CLAUSE.** Any ordinance, resolution, or part thereof that is inconsistent with this ordinance is hereby repealed or modified accordingly.

**SEC. 8. EFFECTIVITY.** This Ordinance shall take effect upon its approval.
