**AN ORDINANCE REVISING THE SCHEDULE OF FEES AND CHARGES ON THE RENTAL OF PUBLIC PLAZA AND ITS FACILITIES, AMENDING FOR THIS PURPOSE CERTAIN PROVISIONS OF MUNICIPAL ORDINANCE NO. 04, SERIES OF 2019, OTHERWISE KNOWN AS THE 2019 REVISED REVENUE CODE OF MONCADA, TARLAC**

**WHEREAS**, the Sangguniang Bayan of Moncada is in receipt of an Executive Request from the Honorable Mayor Estelita M. Aquino, endorsing the revision of fees and charges imposed on the rental of public plaza auditorium and its facilities which include the Auditorium Cafes, Façade, and sound system;

**WHEREAS**, inflation and continued increase in energy prices such as electricity and oil products have put unnecessary strain on LGU's resources, thus, there is a need to cope with the surge and cushion its impact by making a reasonable adjustment to the fees and charges imposed on some income-generating projects of the LGU such as that of rental of public auditorium and its facilities;

**NOW, THEREFORE**, on motion by Coun. Thelmaflor A. Espejo, duly seconded;

**SECTION 1.** Item nos. (2), (3), (4) and (5) of Section 3M.01 of Municipal Ordinance No. 04, Series of 2019 or the 2019 Revised Revenue Code of Moncada, Tarlac are hereby amended to read as follows:

**“Section 3M.01. Imposition of Fee.** Any person that shall temporarily use and/or occupy a road, street, sidewalk, alley, patio, plaza playground or portion thereof in this municipality in connection with construction works and/or other purposes, shall first secure a permit from the Mayor and pay a fee according to the following schedule:


