**MUNICIPAL ORDINANCE NO. 10
Series of 2021**

AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF MONCADA IN THE AMOUNT OF ONE HUNDRED FIVE MILLION PESOS (P 105,000,000.00) TO FUND THE EXPANSION OF EXISTING PUBLIC MARKET, CONSTRUCTION OF SLAUGHTERHOUSE AND CONSTRUCTION OF MUNICIPAL CEMETERY III

Sponsored by: COUN. CLEOFÉ D. FAVIS

BE IT ENACTED by the Sangguniang Bayan of Moncada in session assembled, THAT:

SECTION 1. The Municipal Mayor, Honorable Estelita M. Aquino, in representation of the Municipality of Moncada, hereinafter referred to as the "Municipality", is hereby authorized to enter into a Loan Agreement with the LandBank of the Philippines in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of ONE HUNDRED FIVE MILLION PESOS (P 105,000,000.00) under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with any person, corporation or entity for the purpose of funding priority projects, and subject to the requirements under Section 123 of Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Municipal Mayor shall have full power and authority to represent the Municipality in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements, contracts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted.

SEC. 2. The said priority projects herein specified as the Development Project are hereby certified to be a local infrastructure in accordance with the approved local

development plan and public investment program for the current year 2021 of the Municipality of Moncada.

SEC. 3. Consistent with the covering Resolution No. 42, Series of 2021, contract, deeds and assignment, mortgage contracts, and such other agreements as maybe entered into by the Municipality in connection with the borrowing, the features, terms and conditions shall be as follows and are hereby approved:

NOTE: Interest rates for loan terms 16, 17, 18 are fixed at 4.0% per annum until 31 December 2022 as per RA 11494, interest rate after 31-December-2022 shall be at prevailing LBP rate subject to annual repricing.

SEC. 4. The Municipality hereby appropriates the entire proceeds of the borrowing exclusively to finance the Expansion of Existing Public Market, Construction of Slaughterhouse and Construction of Municipal Cemetery III.

SEC. 5. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

SEC. 6. This Ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an ordinance for its validity, including the affixation of signatures of the Sangguniang Bayan members, in concurrence thereto, composing at least a majority thereof, out of the total of ten (10) members, on all the pages of this Ordinance.
