**MUNICIPAL ORDINANCE NO. 18  
Series of 2021**

**AN ORDINANCE AMENDING SECTION III OF MUNICIPAL ORDINANCE NO. 05, SERIES OF 1997 OTHERWISE KNOWN AS "AN ORDINANCE IMPOSING IMPOUNDING FEES ON VEHICLES INVOLVED IN VEHICULAR ACCIDENTS AND ON ALL OTHER IMPOUNDED VEHICLES"**

On motion by Coun. Janius M. Yasay, duly seconded;

**BE IT ENACTED** by the Sangguniang Bayan of Moncada in session assembled that:

**SECTION 1.** Section III of Municipal Ordinance No. 05, Series of 1997 is hereby amended, to read as follows:

**Section III. Imposition of Fees.**

- 1) Motor Vehicles impounded at the LGU's designated impounding area after twenty four (24) hours shall be charged with an impounding fee of fifty pesos (P 50.00) per day to be settled at the Municipal Treasury and in no case that such fee shall exceed the maximum twenty-five thousand pesos (P 25,000.00) no matter how long they stay at the impounding area.
- 2) Unsettled impounding charges after a release order for the vehicle has been issued by the Court shall require the full payment thereof, otherwise, the LGU shall be compelled to dispose off the vehicle through public auction.

- 3) Motor Vehicles impounded but claimed within twenty four (24) hours shall be exempted from charges.

**SEC. 2. REPEALING CLAUSE.** All ordinances, rules and regulations or parts thereof in conflict with this ordinance are hereby repealed or modified accordingly.

**SEC. 3. EFFECTIVITY.** This Ordinance shall take effect fifteen (15) days following its posting in at least three conspicuous places in the municipality and likewise in the official social media platforms and website of the LGU of Moncada.
