**AN ORDINANCE PRESCRIBING SERVICE FEE FOR ARTIFICIAL INSEMINATION OF
LARGE CATTLE UNDER THE MUNICIPAL AGRICULTURE OFFICE**

WHEREAS, Artificial Insemination (AI), as an efficient alternative in enhancing the propagation of large cattle while improving the resulting breed and preventing the spread of infectious genetically – transmitted diseases, has long been practiced worldwide;

WHEREAS, the Department of Agriculture (DA) sees in the large cattle sector a veritable field of opportunities using the procedure for increased livestock production to achieve self-sufficiency in this particular food item;

Be it ENACTED by the Sangguniang Bayan of Moncada in session assembled, that:

SECTION 1. SERVICE FEE. – There is hereby imposed a service fee for the Artificial Insemination (AI) procedure on large cattle amounting to three hundred pesos (P 300.00) per.

SEC 2. ADMINISTRATIVE PROVISIONS.

- a. The Artificial Insemination service fee shall be paid by the owner at the Municipal Treasurer's office upon presentation of a charge slip or order of payment duly signed by authorized personnel from the Municipal Agriculture Office.
- b. The AI service fee shall be paid before the procedure is done by an agricultural technician.
- c. Only registered cattle shall be allowed to be artificially inseminated.
- d. If the procedure fails during the first attempt, the service fee for the second and third attempts shall be waived.
- e. The Municipal Agriculture Office and the Municipal Treasury shall implement the provisions of this Ordinance.

SEC 3. SEPARABILITY CLAUSE. – If for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

SEC 4. REPEALING CLAUSE. – All ordinances, rules and regulations or parts thereof in conflict with this ordinance are hereby repealed or modified accordingly.

SEC 5. EFFECTIVITY. – This Ordinance shall take effect fifteen (15) days following its posting in at least three conspicuous places in the municipality and likewise in the official social media platforms and website of the LGU of Moncada.
