RECLASSIFICATION OF A PARCEL OF LAND LOCATED AT BARANGAY TUBECTUBANG, THIS MUNICIPALITY, UNDER TRANSFER CERTIFICATE OF TITLE NO. 043-2012006727 FROM AGRICULTURAL TO AGRI-INDUSTRIAL

SECTION 1. AUTHORITY TO RECLASSIFY. - Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an Ordinance reclassifying agricultural lands to non-agricultural and to provide for the manner of their utilization.

SECTION 2. RECLASSIFICATION. - A parcel of land with Transfer Certificate of Title No. 043-2012006727 located at Brgy. Tubectubang, Moncada, Tarlac is hereby RECLASSIFIED from AGRICULTURAL to AGRI-INDUSTRIAL.

SECTION 3. MANNER OF UTILIZATION. The said land shall be strictly utilized in accordance with all applicable laws, rules and regulations particularly the Municipal Zoning Ordinance.

SECTION 4. CONVERSION. - This Ordinance shall not be construed as a conversion order which shall be issued by the Department of Agrarian Reform (DAR).

SECTION 5. This Ordinance shall take effect upon its approval.
