**RESOLUTION NO. 33 – 2018**

**“A RESOLUTION AUTHORIZING PHILIPPINE REGIONAL INVESTMENT AND DEVELOPMENT (PRIDE) CORPORATION TO MEET, STUDY AND DISCUSS ON BEHALF OF THE MUNICIPALITY OF MONCADA, PROVINCE OF TARLAC WITH NATIONAL GOVERNMENT AGENCIES AND INSTRUMENTALITIES THE SPECIFIC TERMS OF THE IMPLEMENTATION OF THE DECISION OF THE SUPREME COURT ON THE PETITION FILED BY FORMER CONGRESSMAN/GOVERNOR MANDANAS ET.AL UNDER SC.GR. NO. 199802 FOR CENTIORARI PROHIBITION AND MANDAMUS WITH PRAYER FOR PRELIMINARY INJUNCTION AND/OR TEMPORARY RESTRAINING ORDER (TRO) INVOLVING THE SUM OF PHP 600 BILLION UNRELEASED INTERNAL REVENUE ALLOTMENT (IRA) TO LOCAL GOVERNMENT UNITS (LGUs).”**

**WHEREAS**, the aforesaid Petition has been filed to seek the automatic release of the full share of the LGUs, also known as Internal Revenue Allotment (IRA) in the Internal Revenue Taxes collected by the National Government, its agencies and instrumentalities, (NG) as provided for in the Constitution and determined by law;

**WHEREAS**, the unreleased amount of IRA collected by the Bureau of Customs as agent of BIR due to the Provinces, Cities, Municipalities, and Barangays from 1992 to 2012 has already reached SIX HUNDRED BILLION PESOS;

**WHEREAS**, compliance by the National Government with the Provisions of the 1987 Constitution and existing laws as regards the full and automatic release of the above-mentioned amount of IRA, will enable the LGUs to hasten delivery of much needed

services to their constituents such as Climate Change Products, Renewable FREE Natural Production, Agri-culture, Agro-culture, Agra-culture, Aqua-culture, Municipal projects roads, bridges, clinics;

**WHEREAS**, there is a need for representation on behalf of the LGUs to discuss and determine with the NG the terms of implementation when the Supreme Court decides the IRA petition in favour of the LGUs;

**PHILIPPINE REGIONAL INVESTMENT AND DEVELOPMENT (PRIDE) CORPORATION** is hereby appointed and authorized on behalf of the Municipality of Moncada, Province of Tarlac to negotiate with National Government, it's agencies and instrumentalities the specific terms of implementation of the decision of the Supreme Court;

It is clear and understood that **PRIDE** will report to LGU the specific terms and conditions arrived at in the above-mentioned negotiations, with National Government, it's Agencies and Instrumentalities for the LGUs' final decision;

**NOW, THEREFORE**, on motion by HON. THELMAFLOR A. ESPEJO, duly seconded by HON. RUBEN V. GAMBOA, JR. be it:

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Philippine Investment And Development (PRIDE) Corporation to Meet, Study And Discuss on Behalf Of The Municipality Of Moncada, Province Of Tarlac With The National Government Agencies And Instrumentalities The Specific Terms Of The Implementation Of The Decision Of The Supreme Court On The Petition Filed By Former Congressman/Governor Mandanas Et.Al. Under Sc. G.R. no. 199802 For Centiorari Prohibition And Mandamus With Prayer For Preliminary Injunction And/Or Temporary Restraining Order (TRO) Involving The Sum Of Php 600 Billion Unreleased Internal Revenue Allotment (IRA) To Local Government Units (LGUs).

**RESOLVED FURTHER** that **PRIDE** is hereby appointed to negotiate on behalf of the Municipality of Moncada, Province of Tarlac with the National Government Agencies and Instrumentalities the specific terms of the implementation of the decision of the Supreme Court;
