**RESOLUTION EXPRESSING SUPPORT FOR THE COURTESY RESIGNATION OF HIGH-RANKING OFFICIALS OF THE PHILIPPINE NATIONAL POLICE WHO HAVE ALLEGED LINK TO ILLEGAL DRUG TRADE, CORRUPTION AND RELATED CRIMES**

**WHEREAS**, in his televised address last January 4, 2023, DILG Secretary Atty. Benjamin C. Abalos, Jr. appealed for the courtesy resignation of high-ranking PNP officials involving full-colonel up to the generals, on the grounds that recent investigations revealed their alleged involvement in the illegal drug trade, corruption and related transgressions;

**WHEREAS**, radical as it may seem, this August Body likewise views that such move may cause demoralization in the entire police force, but this Sanggunian believes in the wisdom of authorities, particularly that of the President and the DILG Secretary who envision a clean slate for the Philippine National Police by weeding out the misfits and scalawags implicated in illegal drug trades;

**WHEREAS**, as duly-elected representatives in the local legislature, we find it proper and fitting to share with the collective call of authorities and citizens alike to root out the PNP of officers who are vested with self-interest that continuously plagues the agency;






