RESOLUTION APPROVING THE PROPOSED CONSTRUCTION OF A FULLY AUTOMATIC CLIMATE CONTROLLED SYSTEM (CCS) POULTRY AT BARANGAYS CALAMAY AND SAN ROQUE OWNED BY RDF FEED, LIVESTOCK AND FOODS, INC.

WHEREAS, RDF Feed, Livestock & Foods, Inc., registered owner of a property in Barangays Calamay and San Roque, this Municipality, has submitted its intent to put up a poultry industry with a capacity of two hundred fifty-two thousand (252,000) heads stocking population on their property;

WHEREAS, the foregoing property was duly reclassified by the Sangguniang Bayan of Moncada pursuant to Municipal Ordinance No. 11, Series of 2019;

WHEREAS, attached to their application are the pertinent requirements, to wit:

1. Letter of Application in the name of the owner of the land addressed to the Sangguniang Bayan
2. Secretary's Certificate for the company's authorized representatives

5. Tax Clearance for the year 2019
6. Tax Declarations
7. Locational Plan / Vicinity Map
8. Detailed description/study of the proposed project
9. Sworn Certificate of Commitment regarding implementation of the project within three (3) years
10. Certification of Non-Irrigation from National Irrigation Administration
11. Certification of Non-Coverage from Department of Agrarian Reform
12. Barangay Resolutions approving the project (Brgys Calamay and San Roque)
13. Social acceptability
14. Certificate of Non-Tenancy
15. Environmental Compliance Certificate from the DENR
16. Zoning Certificate from the Office of the Zoning Administrator

WHEREAS, anent the foregoing premises, the Body interposes no objections to the establishment of the aforesaid business, considering that the location is not within a built-up area and thus falls within the agricultural zone of Barangays Calamay and San Roque as determined in consonance with the Comprehensive Land Use Plan (CLUP) of the Municipality;

WHEREAS, considering too, the socio-economic benefits for Barangays Calamay and San Roque in particular and the entire Municipality in general, the same is hereby found to be of merit-worthy of approval;

NOW, THEREFORE, premises considered and on motion by Coun. Ruben V. Gamboa, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Agriculture and Natural Resources, hereby approves the proposed construction of a fully automatic Climate Controlled System (CCS) poultry at barangays Calamay and San Roque owned by RDF Feed, Livestock and Foods, Inc;
