RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A DATA SHARING AGREEMENT (DSA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR JONATHAN V. DIRAIN IN ORDER TO ACCESS THE RESULTS OF LISTAHANAN 3 PURSUANT TO EXECUTIVE ORDER NO. 867 SIGNED ON MARCH 9, 2010

WHEREAS, the Administrative Code of 1987 mandates the Department of Social Welfare and Development (DSWD) to provide a balanced approach to public welfare by providing an integrated welfare package to its constituents on the basis of their needs and coordinating the service facilities required from such departments or agencies, government and non-government, which can best provide them;

WHEREAS, the same Code also directs the DSWD to formulate, develop and implement plans and projects in the field of social development, identify and deliver appropriate intervention, provide consultative and informative services to institutions and organizations involved in social welfare services;

WHEREAS, under Executive Order No. 867, signed on 09 March 2010, the DSWD, as the lead agency implementing the Listahanan, aims to establish a data management system in identifying who and where the poor households are,

maintain the system that will serve as a repository of data on poor households; update the data every four (4) years and share the data to serve as basis in the selection of beneficiaries of social protection programs;

WHEREAS, as part of the program implementation, the Municipal Government of Moncada will enter into a Data Sharing Agreement (DSA) with the DSWD Field Office III which directs the implementation of social protection and poverty alleviation programs and to allow in securing access to the results of Listahanan 3 database maintained by the DSWD;

NOW, THEREFORE, on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Social Welfare, hereby authorizes the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to enter into a Data-Sharing Agreement (DSA) with the Department of Social Welfare and Development (DSWD) represented by its Regional Director Jonathan V. Dirain in order to access the results of Listahanan 3 pursuant to Executive Order No. 867 signed on March 9, 2010;

RESOLVED, FURTHER, that copies of this Resolution be furnished the Municipal Mayor, this municipality, and the Regional Director of DSWD for their information and appropriate action;
