RESOLUTION CONFIRMING AND AFFIRMING THE APPOINTMENT OF MR. CRISTOPHER JOHN B. PABO AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL HUMAN RESOURCE MANAGEMENT OFFICER) OF MONCADA LOCAL GOVERNMENT UNIT

WHEREAS, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided therein, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, pertinent Civil Service law, rules, and guidelines promulgate that Municipal Government Department Heads shall have the following minimum qualification standard, to wit:

- a. Education: Bachelor's Degree
- b. Eligibility: Second Level (CS Professional or equivalent)
- c. Experience: Three (3) years
- d. Training: None required
- e. Resident of the LGU concerned
- f. Good moral character




