RESOLUTION EXEMPTING THE DON BENITO WINE ECONOMIC ENTERPRISE FROM SECURING A BUSINESS PERMIT FROM THE LGU OF MONCADA

WHEREAS, Moncada being a prime producer of indigenous sweet potatoes sees its vast potential in terms of income generation in the production of a wide array of sweet potato-based products;

WHEREAS, to bring prestige and honor to the town of Moncada, the LGU, through the initiative of Mayor Estelita M. Aquino, ventured into sweet potato processing in 2003;

WHEREAS, the Don Benito Wine, which carries the name of former Mayor Benito E. Aquino, it being his brainchild, was first introduced to the public in 2010, duly recognized by the Department of Trade and Industry as part of the One Town, One Product Philippines program that aims to drive inclusive local economic growth through the promotion of 'pride-of-place' products;

WHEREAS, cognizant of the enormous potential of Don Benito Wine in the promotion of sweet potato-based products as well as additional income source for the LGU, it is but proper and fitting that the same be granted exemption from securing a business permit,


