WHEREAS, submitted for consideration by this August Body is the proposed augmentation of the Annual Budget of Moncada for FY 2022 involving proposed expenditures that would need supplemental appropriations which belong to the same expense class, particularly Other Maintenance and Other Operating Expenses (Other MOOEs);

WHEREAS, in regard to the foregoing, the Local Finance Committee of Moncada submits its recommendation to utilize the LGU's unexpended appropriations from other offices which are earmarked for projects, programs and activities (PPAs) that are deemed not feasibly sound for implementation;

WHEREAS, considering the indispensable need to provide appropriations for more vital PPAs, it is imperative to realign the LGU's resources to other programs which belong to the same expense class pursuant to Section 4 of the Appropriation Ordinance No. 3, Series of 2021, or the Annual Budget of Moncada and Section 336 of the Local Government Code of 1991 (RA 7160);
