**RESOLUTION CONFIRMING ON REVIEW VARIOUS BARANGAY ORDINANCES ENTITLED "AN ORDINANCE AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS, SUBJECT TO THE REMITTANCE OF AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER"**

**WHEREAS**, pursuant to RA 11032 and Moncada Municipal Ordinance No. 15, Series of 2023, the issuance of Barangay Clearance as a requirement for business permit and locational clearance was integrated into the Business Permits and Licensing System of the Municipal Government of Moncada;

**WHEREAS**, DILG Memorandum Circular No. 2019-177 requires all component barangays in every locality to enact their respective ordinances authorizing the Municipal Government to issue barangay clearance and collect corresponding barangay clearance fee in the application for any business-related transactions, subject to the remittance of aforesaid fees to the barangay;

**WHEREAS**, several barangays in Moncada already enacted their ordinances to effect the aforesaid integration;

**WHEREAS**, after a thorough review and study of the provisions of their ordinances, this August Body finds the same to be consistent with existing laws and ordinances;

**NOW, THEREFORE**, on motion by Coun. Janius M. Yasay, duly seconded;
