WHEREAS, the Municipality of Moncada, Tarlac recognizes the critical importance of achieving Zero Open Defecation (ZOD) status in ensuring public health, hygiene, and environmental sustainability;

WHEREAS, the Department of Health issued Administrative Order No. 2019-0054 or the Guidelines on the Implementation of the Philippine Approach to Sustainable Sanitation (PhATSS);

WHEREAS, the Administrative Order aims to achieve Zero Open Defecation (ZOD) status and attain universal access to safe and adequate sanitary facilities by 2028 which are also the goals of the Philippine Health Agenda (2016-2022) and aligned with the health targets of the FOURmula ONE (F1) Plus and the Sustainable Development Goals (SDG) of safely managed sanitation services by 2030;

WHEREAS, the Municipality of Moncada has diligently worked towards implementing sustainable sanitation programs and campaigns aimed at eliminating open defecation and improving sanitation facilities in the community;
