RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE TALON GENERAL HOSPITAL FOR THE PROVISION OF DOH-ACCREDITED AMBULANCE SERVICE AND AS REFERRAL FACILITY OF THE MUNICIPAL HEALTH OFFICE – RURAL HEALTH UNIT I AND II PRIMARY CARE FACILITIES

WHEREAS, the Talon General Hospital located in Tarlac City is a secondary hospital with a DOH-accredited ambulance service and referral facility;

WHEREAS, the Municipal Government of Moncada, Tarlac (LGU), through the Municipal Health Office, is required to comply with the Department of Health Administrative Order No. 2016-0029 entitled Rules and Regulations Governing the Licensure of Ambulances and Ambulance Service Providers, and a referral facility as a requisite in applying for a DOH License to Operate for primary care facilities;

WHEREAS, considering that the LGU has no existing license for ambulance services, the same intends to acquire the services of Talon General Hospital to provide such services to the LGU;

WHEREAS, upon thorough review and perusal of the MOA, the SB, through the Committee on Health, finds the provisions in order and thus, favorably endorses the same for approval;
