**WHEREAS**, Presidential Decree 1096, otherwise known as the National Building Code of the Philippines, serves as a comprehensive framework governing the construction, design, and maintenance of buildings and structures in the Philippines;

**WHEREAS**, the Municipality of Moncada recognizes the necessity of adhering to national standards and regulations in ensuring the safety, convenience, and welfare of its constituents;

**WHEREAS**, the provisions set forth in Presidential Decree 1096 and its Implementing Rules and Regulations encompass vital guidelines, standards, and regulations aimed at promoting resilient and sustainable structures;

**WHEREAS**, it is imperative to enforce the imposition of certain fees and charges as stipulated by the law to facilitate the processing of permits, inspections, and other related services in line with building construction and development;
