RESOLUTION MANIFESTING THE COMMITMENT OF THE MUNICIPALITY OF MONCADA, TARLAC, TO CONTROL AND REGULATE ILLEGAL ACTIVITIES WITHIN THE PERIPHERY OF DAMS AND IRRIGATION STRUCTURES OF THE NATIONAL IRRIGATION ADMINISTRATION (NIA)

WHEREAS, the Municipality of Moncada, Tarlac recognizes the critical importance of preserving and protecting the dams and irrigation structures managed by the National Irrigation Administration (NIA) for sustainable agricultural development and the welfare of the community;

WHEREAS, it has come to the attention of the Sangguniang Bayan of Moncada that there have been rampant and uncontrolled quarrying activities occurring in close proximity to NIA dams and structures in other localities, posing risks to the integrity and stability of these vital facilities;

WHEREAS, the unauthorized quarrying activities within the periphery of NIA dams and structures not only endanger the structural integrity of the said facilities but also contribute to environmental degradation, potential flooding, and other hazards that adversely affect the safety and welfare of the residents in our municipality;

WHEREAS, it is the responsibility of the local government unit to ensure the protection and preservation of critical infrastructure such as NIA dams and irrigation structures within our jurisdiction;

NOW, THEREFORE, premises considered and on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Environment, hereby manifests and expresses its full commitment to control and regulate illegal activities, particularly rampant and uncontrolled quarrying, within the periphery of dams and irrigation structures managed by the National Irrigation Administration (NIA) within the municipality;

RESOLVED, FURTHER, that the Office of the Mayor, in coordination with relevant local government offices and agencies, shall take necessary actions to strictly enforce existing laws, ordinances, and regulations to prevent and address illegal activities near and around NIA dams and structures, including but not limited to conducting regular monitoring, imposition of sanctions, and collaboration with concerned authorities to ensure compliance and promote the safety and welfare of our constituents and farmers alike;

RESOLVED FINALLY, that copies of this Resolution be furnished the National Irrigation Administration, and all concerned for their information and appropriate action;


