**RESOLUTION ADOPTING PRESIDENTIAL DECREE NO. 1619, FDA CIRCULAR NO. 2019-006, AND MUNICIPAL ORDINANCE NO. 2, SERIES OF 1998 FOR THE IMPLEMENTATION IN THE MUNICIPALITY OF MONCADA, TARLAC**

**WHEREAS**, Presidential Decree No. 1619, "Penalizing the Use or Possession or the Unauthorized Sale to Minors of Volatile Substances for the Purpose of Inducing Intoxication or in Any Manner Changing, Distorting or Disturbing the Auditory, Visual or Mental Process," FDA Circular No. 2019-006, "Guidelines in Commercial Display, Selling, Promotion, and Advertising of Alcoholic Beverages and Beverages That Contain Alcohol," and Municipal Ordinance No. 2, Series of 1998, "An Ordinance Regulating the Sale, Catering, Serving and Drinking of Wine and Other Fermented Drinks" aim to regulate the use, sale, and promotion of substances that pose health risks, particularly to minors;

**WHEREAS**, the Sangguniang Bayan of Moncada recognizes the importance of protecting public health, particularly the youth, from the harmful effects of volatile substances and alcoholic beverages;

**WHEREAS**, it is imperative for the local government of Moncada to adopt and implement measures in line with Ordinance No. 2, Series of 1998, PD 1619 and FDA Circular No. 2019-006 to safeguard the well-being of its constituents;

**NOW, THEREFORE**, on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

**RESOLVED**, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, hereby adopts the following measures:

1. To strictly enforce Presidential Decree No. 1619 within the municipality of Moncada, particularly in regulating the use, possession, and sale of volatile substances, ensuring penalties are imposed on violators as prescribed by law;
2. To implement the guidelines outlined in FDA Circular No. 2019-006 and Municipal Ordinance No. 2, Series of 1998, concerning the commercial display, selling, promotion, and advertising of alcoholic beverages and beverages containing alcohol, including the designation of conspicuous areas for display, prohibition of sales to minors, and ensuring promotional materials adhere to specified guidelines;
3. To collaborate with relevant stakeholders, including local businesses, law enforcement agencies, and barangay officials, to effectively implement and monitor compliance with the aforementioned measures;
4. To conduct information dissemination campaigns and public awareness programs to educate the community, particularly parents, guardians, and minors, about the risks associated with the use and abuse of volatile substances and alcoholic beverages;
5. To enact or amend appropriate local ordinances or resolutions to complement and reinforce the implementation of Municipal Ordinance No. 2, s. 1998, PD 1619 and FDA Circular No. 2019-006, as may be necessary.

**RESOLVED, FURTHER,** that copies of this resolution be furnished to the Office of the Mayor, Municipal Health Office, Municipal Police Station, barangay officials, and other relevant agencies for their information and strict compliance
