**RESOLUTION URGING PRIVATE AND BUSINESS SECTORS IN THE MUNICIPALITY OF MONCADA, PROVINCE OF TARLAC TO FORMULATE POLICIES, PROJECTS AND PROGRAMS FOR THE PROTECTION AND PROMOTION OF CHILDREN'S WELFARE IN THE MUNICIPALITY**

**RESOLVED**, that this Sanggunian, acting on the favorable recommendation of the Committee on Social Welfare, Women and Children, hereby earnestly urges the private and business sectors in the municipality to formulate their projects and programs for the protection and promotion of children's welfare in the municipality, to wit;

- 1) The private and business sectors are encouraged to work closely with the local government and civil society organizations in the formulation and implementation of their policies, projects and programs to ensure their effectiveness and sustainability.
- 2) The private and business sectors are called upon to prioritize the needs of the most vulnerable children, such as those who are poor, orphaned, disabled, and victims of abuse and exploitation, in their projects and programs.
- 3) The local government unit, thru the MSWDO, is urged to create a mechanism to monitor and evaluate the projects and programs formulated by the private and business sectors to ensure their compliance with the standards and policies of the municipality and the national government.
- 4) All stakeholders, including the private and business sectors, civil society organizations, the LGU, and the community, are enjoined to collaborate and work together to promote and protect the welfare of children in the municipality of Moncada, province of Tarlac.
