RESOLUTION PROVIDING FOR THE LOCAL MECHANISM OF IMPLEMENTATION OF PRESIDENTIAL DECREE NO. 1569 IN THE MUNICIPALITY OF MONCADA

WHEREAS, Presidential Decree No. 1569, series of 1978, entitled "Strengthening the Barangay Nutrition Program by Providing for a Barangay Nutrition Scholar in Every Barangay, Providing Funds Therefor, and for Other Purposes," aims to address malnutrition problems at the barangay level by establishing a Barangay Nutrition Scholar (BNS) program;

WHEREAS, the Municipality of Moncada recognizes the importance of implementing Presidential Decree No. 1569 to improve the nutrition and quality of life of its constituents, particularly in the barangays;

WHEREAS, there have been newly elected barangay officials following the October 30, 2023 Barangay and SK Elections, necessitating the reaffirmation of the provisions of Presidential Decree No. 1569;

WHEREAS, it is imperative for each barangay in Moncada to appoint a Barangay Nutrition Scholar to effectively deliver nutrition services and related activities to the community;

WHEREAS, there is a need to allocate funds to support programs, projects, activities, and trainings for Barangay Nutrition Scholars to ensure their effectiveness in addressing malnutrition issues in the barangays;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved by the Sangguniang Bayan of Moncada, Tarlac, to adopt the following local mechanism for the implementation of Presidential Decree No. 1569 in the Municipality of Moncada:

- 1) **Mandatory Appointment of Barangay Nutrition Scholars:** All barangays within the Municipality of Moncada are hereby enjoined to mandatorily appoint/re-appoint a Barangay Nutrition Scholar in their respective barangays. The Barangay Nutrition Scholar shall be responsible for delivering nutrition services and related activities, as stipulated in Presidential Decree No. 1569.
- 2) **Allocation of Funds:** The Municipal Government of Moncada shall allocate funds from its annual budget to support programs, projects, activities, and trainings for Barangay Nutrition Scholars. These funds shall cover the expenses necessary to enhance the capabilities of Barangay Nutrition Scholars and ensure the effective implementation of nutrition programs in the barangays.
- 3) **Coordination and Monitoring:** The Municipal Nutrition Committee shall oversee the implementation of Presidential Decree No. 1569 in coordination with barangay officials and stakeholders. It shall also monitor the progress of Barangay Nutrition Scholars and provide necessary support to ensure their success in addressing malnutrition issues in the barangays.
- 4) **Dissemination of Information:** The Municipal Government shall conduct information campaigns to raise awareness about the Barangay Nutrition programs and encourage active participation from barangay officials and residents.
- 5) **Reportorial Requirements:** Barangay officials shall submit regular reports to the Municipal Nutrition Committee regarding the activities and accomplishments of Barangay Nutrition Scholars, as well as the utilization of allocated funds for nutrition programs.

RESOLVED, FURTHER, that copies of this resolution be furnished to the Office of the Mayor of Moncada, Tarlac, the Municipal Nutrition Committee, and all barangay officials for their information and appropriate action.
