RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE ESTELITA M. AQUINO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION IN CONNECTION WITH THE PROPOSED USE OF STA LUCIA ELEMENTARY SCHOOL AS TEMPORARY QUARANTINE FACILITY FOR PERSONS UNDER INVESTIGATION WITH MILD SYMPTOMS OF COVID-19

WHEREAS, the World Health Organization declared the Coronavirus Disease 2019 (COVID-19) as a pandemic due to the rapid increase of cases of infection across nations;

WHEREAS, following the sharp increase in the number of confirmed COVID-19 cases in the country, President Rodrigo Roa Duterte issued Proclamation No. 922 dated March 08, 2020, declaring a State of Public Health Emergency throughout the Philippines and placed the entire Luzon under Enhanced Community Quarantine (ECQ) dated March 16, 2020;

WHEREAS, the Department of the Interior and Local Government, as a member of National Inter-Agency Task Force for the Management of Emerging Infectious Disease (IATF-MEID), issued Memorandum Circular No. 2020-062, promulgating supplementary guidelines on the implementation of Enhanced Community Quarantine in Luzon due to COVID-19 threat;

WHEREAS, since the virus has already entered the Province of Tarlac, the Provincial Government, through the Honorable Governor Susan A. Yap, issued Executive Order No. 10, Series of 2020, placing the entire province under lockdown or "Extreme Enhanced Community Quarantine;"

WHEREAS, one of the critical guidelines integral to the EO is the designation of a temporary quarantine facility in every LGU intended for Persons Under Investigation (PUIs) with mild symptoms;

WHEREAS, relative thereto, the LGU of Moncada has identified Sta Lucia Elementary School in Brgy. Sta Lucia East, this municipality, to be used as temporary quarantine facility for Persons Under Investigation (PUIs) with mild symptoms;


NOW, THEREFORE, premises considered, and on motion by Councilors Alberto C. Marzan, Jr., Thelmaflor A. Espejo and Rodolfo C. Espejo, Jr;

RESOLVED, that this Sanggunian, acting on the favorable recommendations of the Committee on Health, Committee on Education and Committee on Disaster Management, hereby authorizes the Municipal Government of Moncada, through the Honorable Estelita M. Aquino, Municipal Mayor, to enter into a Memorandum of Agreement with the Department of Education in connection with the proposed use of Sta. Lucia Elementary School as temporary quarantine facility for Persons Under Investigation (PUIs) with mild symptoms of COVID-19;

RESOLVED, FURTHERMORE, that copies of this Resolution be furnished the Honorable Estelita M. Aquino, Municipal Mayor, the Department of Education and all concerned agencies and offices for their appropriate action;
