RESOLUTION AUTHORIZING THE ESTABLISHMENT OF THE MONCADA SUPER HEALTH CENTER WITH PERSONNEL COMPLEMENT AND CONSTRUCTION OF ITS BUILDING AT BARANGAY CAMANGAAN EAST, MONCADA, TARLAC, AS AN ADDITIONAL HEALTH CENTER IN THE MUNICIPALITY OF MONCADA, PROVINCE OF TARLAC, PURSUANT TO THE DEPARTMENT OF HEALTH (DOH) HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP) AND AUTHORIZING MUNICIPAL MAYOR ESTELITA M. AQUINO, OR HER REPRESENTATIVE, TO SIGN, DELIVER, AND EXECUTE ALL THE NECESSARY DOCUMENTS IN RELATION THERETO

WHEREAS, the implementation of the Local Government Code of 1991 resulted in the devolution of health services to the local government units (LGUs) which included among others the provision, management and maintenance of health services at different levels of LGUs;

WHEREAS, the Department of Health (DOH) as the prime national health agency, has the authority to provide coherence and direction in enhancing operational effectiveness of local health systems towards improved health status in localities and determine variations in health status which were associated with variations in the performance of health care providers and health care professionals in localities;

WHEREAS, primary health care ensures people receive quality comprehensive care-ranging from promotion and prevention to treatment, rehabilitation and palliative care-as close as feasible to people's everyday environment;

WHEREAS, the Health Facilities Enhancement Program (HFEP) of the DOH aims to improve public health facilities by constructing new and upgrading and rehabilitating existing public health facilities across the country such as barangay health stations, rural health units/urban health centers and local government unit hospitals. The program assists in enabling government health facilities in providing affordable quality care and specialized treatments;

WHEREAS, the Philippines has a shortage in rural health units (RHUs) and health centers. The ideal target is one RHU per 20,000 people;

WHEREAS, the Municipality of Moncada has existing two (2) RHUs for a population of 74,867, and has a gap of two (2) more health centers in order to adequately provide quality health services and reassure accessible healthcare services in the other communities/barangays of the municipality;

WHEREAS, there is a need to establish a health facility in Barangay Camangaan East, Moncada, Tarlac, to be known as the Moncada Super Health Center, which shall cater to the health needs of the locality and that of the surrounding localities, and inevitably help to bridge the gap of health centers which are required to provide primary health care services in the rural areas;

WHEREAS, the Moncada Super Health Center, in order to function properly, effectively and efficiently, must be provided with a proper, suitable health care facility or a building, as well as a separate set of staff such as doctors, dentists, nurses, midwives, medical technologist and other cadres, as stipulated in the National Objectives for Health (NOH) 2017-2022;

WHEREAS, the 2023 National Expenditure Program provides the amount of Ten Million Pesos (P10,000,000.00) for the infrastructure and Two Million Pesos (P 2,000,000.00) for the medical equipment of the Moncada Super Health Center, through the initiative of Tarlac 1st District Representative Hon. Jaime D. Cojuangco and Kabayan Partylist Representative Hon. Ron P. Salo and as provided under the Health Facilities Enhancement Program of the Department of Health which gears toward the government's mandate to provide universal health care under the Universal Health Care Act (RA 11223);

WHEREAS, it is to the utmost benefit of the Municipality of Moncada, Tarlac and its people, that the Moncada Super Health Center be established, with personnel complement, and its building constructed to support the municipality's quality healthcare provision for its constituents; and to contribute general progress to the community;

NOW, THEREFORE, on motion by Coun. Alberto C. Marzan, Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, hereby authorizes the establishment of the Moncada Super Health Center, with personnel complement, and construction of its building
