**WHEREAS**, the Municipal Government of Moncada, Tarlac recognizes the challenges faced by taxpayers and business owners in renewing their business permits and fulfilling their tax obligations;

**WHEREAS**, it has come to the attention of the Municipal Government that a significant number of taxpayers and business owners have yet to renew their business permits and settle their corresponding taxes;

**WHEREAS**, in order to support and alleviate the financial strain on businesses in Moncada, it is deemed necessary to extend the deadline for the payment of business taxes and other recurring regulatory fees pursuant to Section 167 of Republic Act 7160 or the Local Government Code of 1991;

**NOW, THEREFORE**, on motion by Coun. Thelmaflor A. Espejo, duly seconded;

**RESOLVED**, that this Sanggunian, acting on the favorable recommendation of the Committee on Finance, Ways and Means and Appropriations, hereby extends the payment of business taxes and other recurring regulatory fees
