RESOLUTION CONFIRMING ON REVIEW SAN LEON BARANGAY ORDINANCE NO. 01, SERIES 2024 OR "AN ORDINANCE ADOPTING THE NEW SEAL OF BARANGAY SAN LEON MONCADA, TARLAC AND FOR OTHER PURPOSES," AS VALID AND WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY

WHEREAS, Section 22 of RA 7160 or the Local Government Code of 1991 provides that a local government unit may modify or change its corporate seal and shall be registered with the DILG as provided in the aforesaid law;

WHEREAS, relative to the foregoing, the Sangguniang Barangay of San Leon enacted Barangay Ordinance No. 01, Series 2024 to distinct itself from its resemblance with the seal of the municipality, and give stronger identity consistent with the ideals and characteristics of their barangay, hence, the modification thereof;

WHEREAS, upon thorough review of the provisions of the said barangay ordinance, the SB, upon recommendation of the Committee on Ordinances and Legal Matters, finds the same to be within the conferred powers of the Sangguniang Barangay and consistent with the provisions of existing laws;
