AQUINO, TO ENTER INTO A USUFRUCT AGREEMENT WITH THE MONCADA WATER DISTRICT RELATIVE TO THE USE OF THE LGU PROPERTY IN BRGY. SAN JULIAN FOR THE PURPOSE OF CONSTRUCTING, UTILIZING, AND MAINTAINING A WATER SYSTEM FACILITY THEREAT


