RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A USUFRUCT AGREEMENT WITH THE EMPOWERED MONCADENIAN ASSOCIATION OF PWDS, INC. (EMAPWD, INC.) FOR THE USE OF A PORTION OF THE PDAO BUILDING INTENDED FOR THE "BIGASAN CENTER," A LIVELIHOOD PROJECT OF THE PESO TARLAC PROVINCE AND DOLE

WHEREAS, it is the duty of the Sangguniang Bayan to promote the welfare and well-being of all constituents, particularly those belonging to vulnerable sectors such as Persons with Disabilities (PWDs);

WHEREAS, the Empowered Moncadenian Association of PWDS, Inc. (EMAPWD, Inc.) has demonstrated a commitment to uplifting the lives of PWDs within the municipality of Moncada, Tarlac;

WHEREAS, the establishment of a "Bigasan Center" as a livelihood project by the PESO Tarlac Province and the Department of Labor and Employment (DOLE) is a significant endeavor aimed at providing sustainable livelihood opportunities to marginalized sectors;

WHEREAS, the use of a portion of the Persons with Disabilities Affairs Office (PDAO) building for the "Bigasan Center" project aligns with the municipality's objectives of inclusivity and empowerment of PWDs;

WHEREAS, a usufruct agreement between the Municipal Government of Moncada, represented by Mayor Estelita M. Aquino, and EMAPWD, Inc. for the

utilization of the specified portion of the PDAO building is deemed necessary to facilitate the implementation of the "Bigasan Center" project;

NOW, THEREFORE, on motion by Coun. Thelmaflor A. Espejo, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Labor and Employment and Livelihood, hereby authorizes the Municipal Government of Moncada, Tarlac, through the Honorable Mayor Estelita M. Aquino, to enter into a usufruct agreement with the Empowered Moncadenian Association of PWDs, Inc. (EMAPWD, INC.) for the use of a portion of the PDAO building intended for the "Bigasan Center," a livelihood project of the PESO Tarlac Province and DOLE;
