RESOLUTION AUTHORIZING THE HONORABLE RAMON BENITO M. AQUINO, ACTING MUNICIPAL MAYOR, TO SIGN VOUCHERS, CHECKS AND ALL WARRANTS DRAWN FOR THE EXPENDITURES OF THE MUNICIPALITY OF MONCADA FROM APRIL 30 TO MAY 6, 2024, INCLUSIVE DATES

WHEREAS, the Honorable Mayor Estelita M. Aquino is filing her leave of absence from April 30 to May 6, 2024, inclusive dates, for travel abroad;

WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, specifically Section 46, provides that the Vice Mayor shall exercise the powers and perform the duties and functions of the Municipal Mayor in case of temporary vacancy, except for the power to appoint, suspend and dismiss employees;

WHEREAS, the SB is in receipt of a Special Order from the Office of the Mayor designating the Honorable Vice Mayor Ramon Benito M. Aquino as Acting Municipal Mayor effective April 30 to May 6, 2024, inclusive dates;

WHEREAS, under Section 444 (b) (vi) of the Local Government Code of 1991, the Local Chief Executive has the authority to sign checks and all warrants drawn from the municipal treasury intended for the operation of the municipality, to which appropriations therefor shall be derived from the General Fund (GF), Trust Fund (TF) And Special Education Fund (SEF);

WHEREAS, the foregoing duties shall therefore be assumed by Vice Mayor




