AQUINO, TO ENTER INTO A DEED OF USUFRUCT WITH THE SUPREME COURT OF THE PHILIPPINES FOR THE GRANT OF BENEFICIAL USE OF THE MUNICIPAL CIRCUIT TRIAL COURT BUILDING IN BRGY. POBLACION 4, MONCADA, TARLAC**

**WHEREAS**, the Municipality of Moncada, Tarlac recognizes the importance of supporting the judiciary to ensure the efficient administration of justice;

**WHEREAS**, the Supreme Court of the Philippines has expressed its need for the beneficial use of the Municipal Circuit Trial Court building located in Brgy. Poblacion 4, Moncada, Tarlac registered under the name of the Municipality of Moncada;

**WHEREAS**, the Local Government Code of 1991 (Republic Act No. 7160) authorizes local government units to enter into usufruct agreements with other entities for the purpose of promoting public welfare;

**WHEREAS**, the grant of beneficial use of the said building to the Supreme Court of the Philippines will enhance the delivery of judicial services in the locality and benefit the residents of Moncada, Tarlac;
