RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO ENTER INTO A RETURN SERVICE TRIPARTITE AGREEMENT WITH THE UNIVERSITY OF THE PHILIPPINES MANILA SCHOOL OF HEALTH SCIENCES TARLAC CAMPUS AND THE SCHOLARSHIP NOMINEES FROM MONCADA

WHEREAS, endorsed to this August Body is a proposed tripartite Return Service Agreement (RSA) among the LGU, the grantees of academic scholarships for health science courses, and the University of the Philippines Manila School of Health Sciences Tarlac Campus that offers ladderized health courses for LGU's qualified nominees;

WHEREAS, the LGU, considering the need for health human resources in its area, is endorsing another batch of nominees/grantees to study at the UP Manila-School of Health Sciences (SHS) Tarlac Campus;

WHEREAS, the nominees/grantees shall agree to render health-related services in underserved areas of the province at a rate of two (2) years for every year of training and schooling in accordance with the return service agreement with UP Manila SHS;

WHEREAS, under the agreement, the LGU commits itself to pay its counterpart fees to the University as required by the program and provide other
