RESOLUTION WITHDRAWING FROM THE SANGGUNIANG PANLALAWIGAN OF TARLAC THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR FY 2024 AND APPROPRIATION ORDINANCE APPROPRIATING FUNDS FOR SUPPLEMENTAL BUDGET NO. 1 FOR FISCAL YEAR 2024 OF THE MUNICIPAL GOVERNMENT OF MONCADA, TARLAC IN THE TOTAL AMOUNT OF TWELVE MILLION FOUR HUNDRED EIGHTY-FIVE THOUSAND PESOS (P 12,485,000.00) COVERING VARIOUS EXPENDITURES FOR VARIOUS PROGRAMS, PROJECTS, AND ACTIVITIES OF THE MUNICIPAL GOVERNMENT
